Examination Scheme:

MBL candidates are expected to write 100 marks in-class examination for all the five papers & Diploma candidates for paper I to IV. Annual examination is held in June and the Supplementary examination in December/January. Grading system is followed for evaluation of performance. Minimum 'B' Grade (50% marks) is required to pass a paper. A minimum Cumulative Grade Point Average (CGPA) of 3.00 out of 7.00 is necessary to complete the course.

Diploma candidates are expected to write a dissertation on the suggested topic for Paper V. The dissertation is evaluated for 80 marks. Further the students are expected to take an oral exam-viva voce, which will be based on the dissertation they write. The vive voce would carry 20 marks. Dissertation must be submitted one month before the examination.
